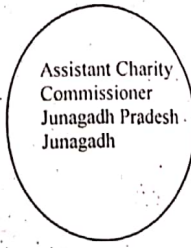

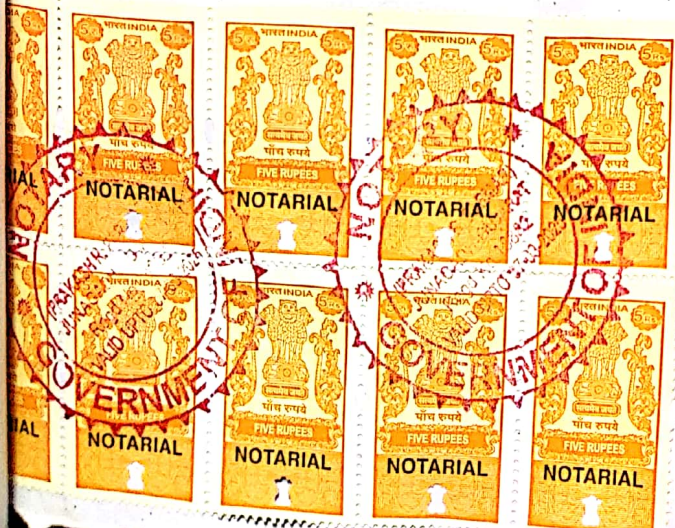

The document of establishment of this trust dated : 17/07/2021 Saturday at Junagadh. On one side of this document Miss Joshi Sheetalben Pradyumanbhai hereinafter referred to as settlor. will come and on the other side the names of all Mr. Trustees

- (4) Shree Bhatt Madhuben Rameshchandra
- (5) Shree Joshi Pradyuman Ratilal

All Hindus, U.V. adult, are formed between. The parties on the other side shall hereinafter be addressed as Trustees. The trust arising out of this document will be a political less and a non-removable irrevocable trust for public charitable purposes. The settlor of this document has separated Rs.101/- from his self-acquired property to the trust. Over which he or his descendants will not have any right. The name and purpose and rules of this trust will be as follows.

The name and purpose and rules of this trust shall be as follows.

(1) Name of this trust:-

Shree Hiradip Charitable Trust -- Junagadh

2) Office and area of operation of this trust :-

The head office of this trust will be located at Miss Joshi Sheetalben Pradyumanbhai Junagadh, -- Madh Street, Opposite Paras Apartment, Near Wad Faliya, Junagadh. Sub office or offices can be started elsewhere. The scope of this trust will be limited to the entire country of India.

(3) Objectives

The objectives of this organization are to carry out the

following activities without discrimination of caste, creed or caste.

(1) Educational activities:-

1) Kindergartens, Kindergartens, Kindergartens, Primary, Upper Primary, Intermediate, Higher Secondary Schools, Schools, Colleges, Educational Institutions, Ashramshalas Computer Education, Anganwadis and Higher Education Institutions for study

Establish. Run. 7) So to establish, run, maintain vocational technical courses like ITI Computer Technology, Cyber Technology, Electronics Technology, Mobile Technology training years and to seek assistance and provide assistance to such running institutions.

8) use To establish, run, maintain and provide free or concessional facilities in hostels, hostels for students studying in schools, colleges or other educational institutions.

10) To establish, run and maintain schools for poor people, educational institutions related to different professions, colleges, hostels.

11) To provide assistance to the deaf and dumb and to open, run and maintain their schools and colleges to educate them.

(2) Medical purposes :-

1) To establish, operate or maintain public hospitals, dispensaries, Nasirghome laboratories, Acre clinics, sonography clinics, medical facilities for the prevention of various diseases.

2) Driving and maintaining ambulances and subways.

3) To run and maintain dispensaries and mobile dispensaries.

4) To provide financial support to public institutions with medicinal purposes and to assist in any other way to carry out Ayurvedic related activities.

5) Carrying out activities to provide free or subsidized medical assistance or treatment to the poor, disabled, disabled and needy people, including operation, medicine and accommodation for treatment, etc. Doing all kinds of work related to medical purposes.

6) Helping needy students in the medical field by giving scholarships or loans or in any other way for higher studies.

7) Conducting research for medicine for various diseases and incurring necessary expenses for the same and helping the person or organization conducting such research.

8) To run and maintain its research centers for the treatment of various diseases in the medical field, and also to run and maintain blood banks with the intention of making blood easily available to the weaker sections of the society.

9) To organize blood donation camps and disease diagnosis camps and to organize medical camps of different eminent doctors with the intention of benefiting the weaker sections of the society and to provide services to the patients.

10) To run Ayurvedic clinics and hospitals and to treat stubborn patients.

(3) Other Charitable Purposes :-

1) Providing gram seeds to animals and birds and arranging deserts for chabutras, and also constructing water parves.

2) Feeding batuk for small children in schools in the surrounding villages.

3) To provide financial assistance, scholarships to the children of poor economic background studying in school.

4) To provide medical treatment assistance to blind and disabled needy poor persons and widows.

5) Social works, social reform works, de-addiction and inspiring youth. To perform guidance information tasks

6) Provide food, clothing, residential campus, cash and rehabilitation and business stability to the people affected by natural and unnatural calamities like fire, accident, riot, flood, earthquake.

7) To establish, run, maintain and administer Ashrams for orphans, old age, disinherited people and to assist and obtain assistance from other institutions running therein.

(5) Number of Trustees:-

The number of trustees of this trust shall be at least 3 (three) and 11 at most more.

(6) Accounting year:-

The accounting year of this organization shall commence from 1st April and shall end on 31st March.

Establishment of immovable property of the trust :-

The establishment of the property of this trust shall be in the trustees mentioned clause no. 7 of this document and in the trustees appointed from time to time.

9) Manner of appointment of trustees :-

1) Trustees shall be for life

(2) The position of a trustee falling vacant for any reason and the position of a trustee currently lying vacant shall be filled by the remaining trustees by majority vote of any person.

(10) Office bearers :-

The office bearers of this organization will be the President and the Minister.

Pramakh :-

1) The President shall be the Executive Committee and the head of the organization.

2) All the activities and functions of this organization will be carried out as per the instructions of the President.

3) The President shall have the right to cast one additional vote.

(11) Powers and Duties of the Board of Trustees :-

which may sell, mortgage, gift or otherwise transfer the immovable property of the Trust subject to the laws relating to the Gujarat Public Trust Act for the being.

Trust money can be invested subject to law.

The documents of ownership of the immovable property of the trust shall be kept in its possession at the office of the trust or in a safe deposit vault in a bank.

- 4) Will maintain the trust property. Will take steps for his safety.
- 5) It will always be active to fulfill the purposes of the trust.
- 6) The trustees can be entrusted with the work of this trust by fear.
- 7) If any of the trustees have incurred expenses for the work of this trust out of their personal money, then they will be entitled to take the amount of those expenses from the trust.
- 8) Donations, funds or contributions may be accepted subject to conditions not inconsistent with the name and purposes of this trust.

(12) Quorum :-

The quorum of the meetings of the Board of Trustees when the number of trustees is three, will be considered as completed by the presence of two or 1/2 of the trustees. The meeting adjourned for lack of quorum will be held again for one hour. In which the barrier of quorum will not be disturbed.

(13) Resolution Book :-

- 1) A minute book of the organization shall be maintained.
- 2) A note of all proceedings taken in the meeting will be written. It has to be signed by the President as well as the Minister.
- 3) In unavoidable circumstances, a circular resolution can be passed through a circular, which will be noted in the resolution book.

(16) Modification:-

The Board of Trustees may, by a resolution of 2/3rd majority, modify, amend, increase or decrease the provisions of the Trust Deed when occasion arises to modify any clause of this Trust Deed.

(17) Dissolution or Amalgamation of the Trust:-

1) In any case, when the question of dissolution of this institution arises at any time in the future, the Board of Trustees may, by a detailed majority resolution, take a decision regarding the properties of the trust and may dissolve the trust. In these circumstances, all the members of the first institution Kind responsibility will be fulfilled first. And thereafter the amount or property which increases shall be transferred to a registered trust having the same purpose. And thereafter the Trust may be declared closed as per the provisions of the Gujarat Public Trust Act-1950.
